DEFAULT, ATTORNEY FEES, GOVERNING LAW & VENUE: Applicant agrees to pay WMC for all expenses, costs, collection agency costs, and attorney fees incurred or expended by WMC to collect amounts due from Applicant pursuant to these Terms and Conditions and the terms of any invoice from WMC, whether a lawsuit or other legally proceeding is commenced or not. Applicant agrees that the laws of the State of Utah shall govern all transactions and agreements between WMC and Applicant and any enforcement or lawsuit relating to said transactions and agreements shall be brought in the state or federal court located in Salt Lake City, Utah. Applicant expressly waives all venue rights and consents to the exclusive enforcement of this and any other agreement with WMC = in Salt Lake County, Utah.
