By signing below, Applicant agrees, represents and warrants the ability and willingness to pay for any and all invoices at the time of sale with cash, check, or credit card prior to taking possession of parts and/or equipment.

**DEFAULT, ATTORNEY FEES, GOVERNING LAW & VENUE:** Applicant agrees to pay IMT for all expenses, costs, collection agency costs, and attorney fees incurred or expended by IMT to collect amounts due from Applicant pursuant to these Terms and Conditions and the terms of any invoice from IMT, whether a lawsuit or other legally proceeding is commenced or not. Applicant agrees that the laws of the State of Utah shall govern all transactions and agreements between IMT and Applicant and any enforcement or lawsuit relating to said transactions and agreements shall be brought in the state or federal court located in Salt Lake City, Utah. Applicant expressly waives all venue rights and consents to the exclusive enforcement of this and any other agreement with IMT in Salt Lake County, Utah. If Applicant becomes insolvent or if Applicant breaches any term or condition herein, or breaches any other agreement between IMT and Applicant, or if for any reason IMT deems itself insecure, IMT may terminate the agreement and close the cash account immediately. **Applicant expressly waives sovereign immunity with respect to any default hereunder and under any other agreement with IMT.** The failure of Applicant to make timely payment in full pursuant to this Application or pursuant to the payment terms set forth in the applicable invoice shall be deemed a material breach of these Terms and Conditions. Applicant shall pay interest in the amount of twenty four percent (24%) per annum or two percent (2%) per month to IMT or any amount due that is not timely paid, until such amount is paid in full.
